GC Deputy John Robert Street dies in the line of duty on Dec. 16

George County, MS – It is with great sorrow that we announce the line of duty death of Deputy John Robert Street, 24. Shortly before 02:00 a.m. this morning, while responding to an accident on Highway 57 North, that Deputy Street was killed when his vehicle left the road and struck a tree.

Deputy Street was a fulltime officer with the Lucedale Police department and a part time officer with the George County Sheriff's Office and it was while on duty with the George County Sheriff's Office that he lost his life.

Deputy Street had been in law enforcement for approximately 4 years. We ask for prayers for his family and the officers and staffs of the George County Sheriff's Office, and the Lucedale Police Department.

Arrangements for Deputy Street will be announced as soon as they become available.
