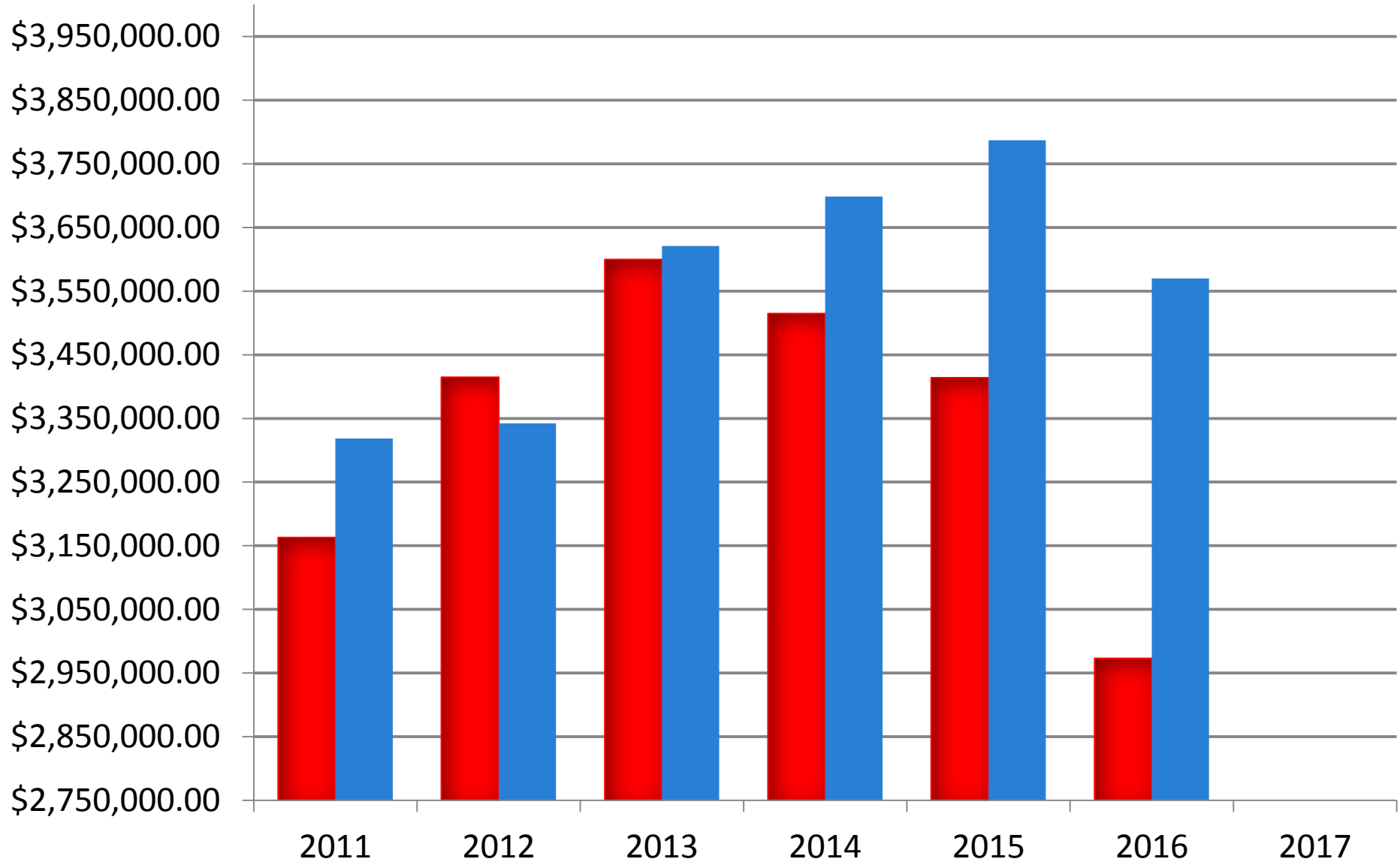

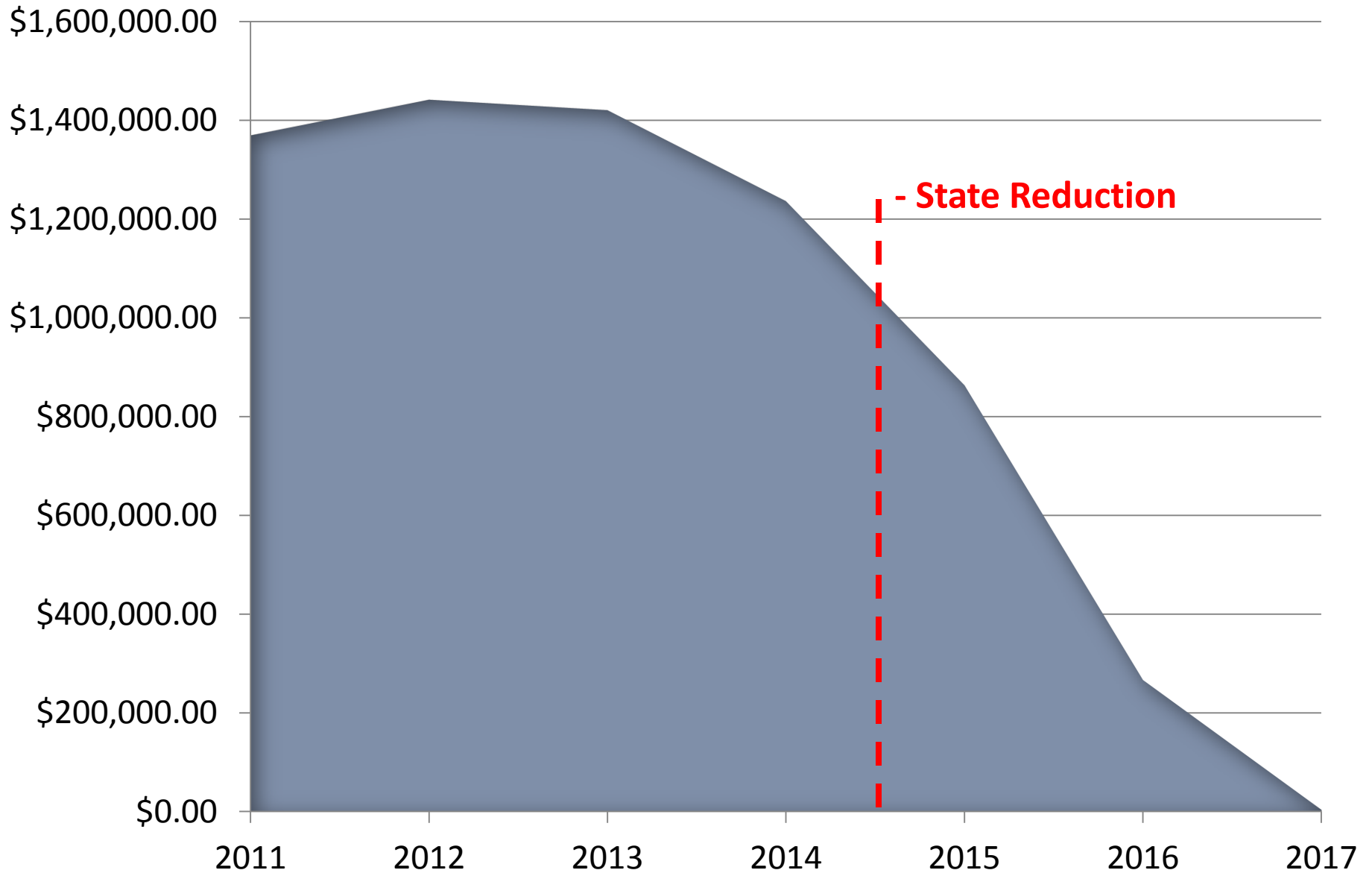

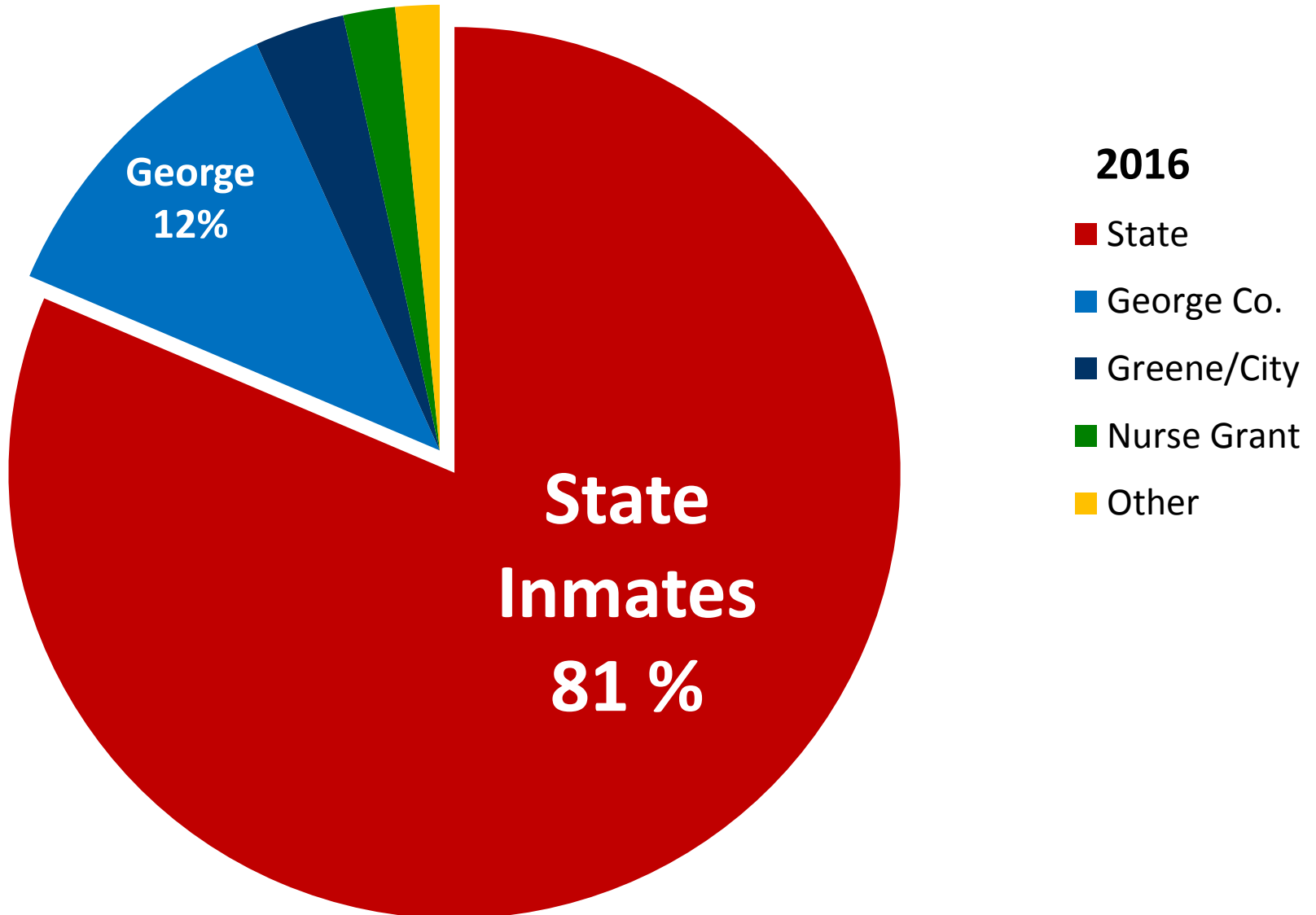
JAIL REVENUE vs EXPENSES
