## Stanley Anderson Reaches 35 Years of County Service

Mr. Stanley worked through many hurricanes (approx. 15) and had four bosses. Mr. Larry McDonald is the current Supervisor for District 3. Mr. Ralph Fairley was the supervisor when Stanley began and he credits Mr. Fairley with teaching him a great deal. A major change according to Stanley is the road equipment. Stanley says the road grader machine is

the biggest improvement over the years and, of course, air conditioned cabs.

3 lbs. frying chicken

1 c. chopped green pepper

1/2 lb. ham, cubed

3 T. vegetable oil

1 c. chopped onion

## Quarterly Recipe "Chicken Jambalaya"

Courthouse Cancer

1 clove garlic, minced 2 tsp. salt 2 tsp. Worcestershire sauce 1/4 tsp. thyme

1/4 tsp. tabasco sauce1/4 tsp. black pepper3 c. chicken broth1 1/2 c. uncooked rice

Cut chicken up, leaving meat on the bones. Brown chicken and ham in oil. Remove meat. Sauté peppers, onion and garlic 5 minutes over low heat. Add seasonings and broth. Simmer 10 minutes. Add rice and meat. Cover and cook over low heat 25 minutes. Fluff rice with fork and cook 5 minutes longer.
